In exercise of the powers conferred by section 109 of the Kerala Co-operative Societies Act, 1969 (Act 21 of 1969), the Government of Kerala hereby make, the following rules further to amend the Kerala Co-operative Societies Rules, 1969, the same having been previously published under Notification No. Co-Op-B1/48/2021/Co-op dated 16<sup>th</sup> October,



2021, in the Kerala Gazette Extra Ordinary No. 3012 dated 16<sup>th</sup> October, 2021, as required by sub-section(1) of section 109 of the said Act namely:-

## RULES

*1. Short title and commencement.*- (1) These rules may be called the Kerala Co-operative Societies (1<sup>st</sup> Amendment) Rules, 2022.

(2) They shall come into force at once.

*2. Amendment of the Rules .-* In the Kerala Co-operative Societies Rules, 1969, in sub-rule (10) of Rule 185, for the existing proviso, the following provisos shall be substituted, namely:-

“ Provided that the above sub-rule shall not be applicable to those employees, who are in the sub-staff category as on 25<sup>th</sup> November, 2014 as per feeder category sub-rules approved by the Registrar / Joint Registrar:

Provided further that the above shall not be applied to the Co-operative Societies where the Board of Directors have already taken resolution for direct appointment and the procedures for direct appointment has already initiated:

Provided also that the seniority of those employees appointed in the post of clerk by promotion and direct recruitment shall be on the basis of their date of order of promotion and date of advice for appointment, as the case may be”.

## Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-clause (10) of Rule 185 of the Kerala Co-operative Societies Rules, 1969 specifies the appointment and promotion to the posts of clerk in all Primary Co-operative Societies / Banks and Primary Agricultural and Rural Development Bank. It was decided to amend sub-rule (10) of Rule 185 so as to get promotion to all sub-staff in service up to 25<sup>th</sup> November,



2014. The draft rules were previously published as required under Sub-section (1) of Section 109 of the Kerala Co-operative Societies Act, 1969 (Act 21 of 1969) as Notification No. Co-Op B1/48/2021/Co-Op dated 16<sup>th</sup> October, 2021 in the Kerala Gazette Extraordinary No. 3012 dated 16<sup>th</sup> October, 2021 inviting suggestions or objections, if any, in respect of the said draft rules. After considering the objections and suggestions it is decided to finalise the same.

This notification is intended to achieve the above object .
